In the municipality of Santa Cruz de la Sierra, Department of Santa Cruz, of the Plurinational State of Bolivia, at 17:37 hours (seventeen thirty-seven), on Friday, the first day of August, two thou-sand twenty-five, BEFORE ME, YOSELYN PRISSILA ARTEAGA MOYA, Notary Public No. 121 of the municipality of Santa Cruz de la Sierra, Department of Santa Cruz, appeared Ms. LILIANA GABRIELA ZELADA RUCK, with Identity Card No. 1069015 (one, zero, six, nine, zero, one, five), Bolivian, single, public servant, residing at B/SANTA ROSITA C/PORONGO Nº61, appearing in her own right as APPLICANT; and Mr. FERNANDO LUIS ARCE CASTELLON, with Identity Card No. 3 393642 (three, three, nine, three, six, four, two), Bolivian, married, entrepreneur, residing at C. 21 . NRO. 222 - Z. ACHUMANI, appearing in his own right as APPLICANT.

Who appeared before this notarial office to request a verification of certain vaccines and phar-maceutical medications, which consisted of the following:

At the request of LILIANA GABRIELA ZELADA RUCK, Identity Card N° 1069015, a medical odon-tologist, and FERNANDO LUIS ARCE CASTELLON, Identity Card N° 3393642, at 8:30 a.m. on July 22nd of this year, I proceeded to a property located in Plaza 24 de Septiembre, to the press room of the government, to observe, using microscopes, the evolution of the samples in my pos-session according to the previously made record of request and verification. In attendance were Doctor LILIANA GABRIELA ZELADA RUCK and Mr. FERNANDO LUIS ARCE CASTELLON. I de-livered to them respective microscope slides containing samples of the diluent liquid used for reconstituting the vaccine, which had been analyzed the previous day. The procedure performed yesterday was repeated, after which the doctors issued the following report: "An evolution of self-assembled nanotechnology is observed. Over the course of yesterday to

THE FOLLOWING IS A TRANSCRIPTION OF ALL THAT WAS EXPRESSED BY DOCTOR LILIANA GABRIELA ZELADA RUCK:

ANALYSIS OF THE MEASLES VACCINE.- This bubble is of technological origin; it was not present yesterday. I want it clearly noted that it is completely new. Look, that is a new formation. Here there are more little things; it's a small stick. Let's see, here is another one. This is also hydrogel, the hydrogel that we are denouncing. Here there is a tape; everything illuminates as we have seen. There are more substances there. Let's take a look around; there are many little things there, but above all I want to look here. Here we have an image. Look at this. Yesterday it probably existed, but smaller, and now we have a large image. All those little pieces, look, are contamination. There, there is the hydrogel. The hydrogel is tremendously important. Vesicles are already forming. Here we already have a vesicle, graphene oxide in a tape, in a sleeve, look how it is being integrated; there it is. And that appeared between yesterday and today, which is tremendously impactful, more images. Therefore, we want to clarify that the measles vaccine being administered to our poor children, and which is likely the cause of their illnesses, contains another hydrogel; this is another hydrogel. Observe how it illuminates. Observe that. So, this is a tape, probably osseous graphene, and two hydrogels, two hydrogel bubbles ready to merge and transform into, who knows what. Therefore, it is demonstrated once again, there is another bubble. This is very clear.

It was evident yesterday, and as the hours and days pass, it will become much more noticeable. Those filaments may be hydroxides. Here is a beautiful ribbon too, and two more; and not only that—this is not a ribbon, but we have around it those two, three, four graphite particles. But look here. This is the famous hydroxide, the exact composition of which we do not know, but it is tremendously poisonous. The center illuminates the hydrogel intensely; it's remarkable. A large quantity of contaminants. Exactly, here it has colors, you see, in the blue. This is all excessive. Let's see if we can find more things. We could be, that's what I'm saying, we could be searching for more small details for a long time. How it has grown, how that is growing. Here is another strand with the hydrogen bubble. Yes, I'll return tomorrow to search; I can no longer find these substances, as they would all be self-assembled by now. Generally, I try to note their position, search for them, and then I can no longer find them. They have already transformed into something else. Therefore, once again, I urge the public, especially parents, to demand that the authorities conduct analy-ses and require informed consent; that a physician, let's see, here is a large one, that a physi-cian signs and accepts responsibility for what is being administered to their children. There is another strand there; there are more around it. Look at the size; it's impressive. This could already be an implant, an antenna. We are seeing that vaccinated people already have a MAC address and are linked to the cloud. It's not only from the COVID vaccines; it could be from these as well, because here we are in contact with the technology. It's fine, it's quite a bit. Another long ribbon.

Look at the size; this wasn't here yesterday. So, to clarify, all those small dots, all those small dots are the ones that join together and form this swarm.

It must be considered that atomic machines are constructed atom by atom . So, here we are seeing enormous structures that, if constructed atom by atom, would have a different shape. We are going to finish with this image, which shows a capeno bone ribbon, tested capeno bone. You can see 1, 2, 3, 4, 5, 6, 7, and some smaller ones here, and obviously the hydrogen bubble; there it is. So, it is guite noticeable. And tomorrow, when I make the video, I will look for it, but this will probably be gone; it will grow. So, all these particles that are around it will be introduced into this mass, and others will form as well. Now we will focus on them. There they are. And they will be altered, and a whole apparatus is forming. This is incredible.

And there are more here; we could be here a long time, but look. And if we had put it at body temperature, there would have been more significant changes, right? Probably, and certainly if we put it in front of the Wi-Fi, or if we were near antennas we are in the city center, I imagine there must be antennas nearby but the doctor has gone to her house, and I don't know; she probably doesn't live very close to antennas, or things that could have formed even more, right? Because if she were, for example, in front of an antenna, this would probably have self-assembled much faster, since it will self-assemble over time anyway. That's the idea. What's the temperature? The temperature is 36 degrees, right? 37. 37? When you do it with your breath? Ah, yes. If I activate it with my breath, obviously it will look for something more, and we move on to another one, since we have several to see. But you see, this very formation is the one found in

COVID, AND the one that, for example, Doctor Ricardo Delgado has identified in the incubus issue. All these formations, these anesthetics, everything contains that, and I imagine they are sharps. Well, then, we are going to save it again. Now.

THE ANTITETANUS VACCINE IS ANALYZED. - That is the antitetanic one. This is the antitetanus vaccine; we already see another possible implant as well, or a possible antenna, or a tape of possible graphene oxide. Everything is possible, proba-

ble, because we already have the international studies, but I cannot say definitively, only based on what we have seen in the studies of Doctor Compra, and all the Nixons, the Germans, and all the organizations, independent people, independent scientists. And there are Two dimensions; here the dimensions are very clear. There is one, and if you look from behind, that's another, a probable hydrogel, another form of hydrogel. Look, look, this that has formed here is the excess, but notice, the same is also present in the COVID vaccine, and they exhibit these ramifications, and there are ribbons. This is the tetanus toxoid; look at those. This is truly a very high technology. There is another little stick; there is another little glass, too. None of that was there yesterday. Yesterday there was none of that; that is what we want to show in the self-assembly. And as the days go by, this gets more complicated, right? It gets more complicated.

Look here, here is the hydrogel, and apparently, the hydrogel indicates that the tetanus toxoid also has nanotechnology. The colors are impressive. All of this has formed within 24 hours.

DICLOFENAC IS ANALYZED.- We are now going to examine diclofenac. Look this is a film, but the back part has these sharp projections. That's what is concerning. Look at all those little pointed things. This is often seen in anesthetics. What is all that? Dr. Liliana Continues With The Explanation.- This is articaine. Here, the cord has already formed. Here, we already have this cord. It is exactly the same technology as in COVID vaccines. There is the cord. This will become a vesicle. And there will be a prism, and they do not know what the prisms are for. But look how it has already formed. Much more, more than anyone else.

It's already spread across the entire drop. This strand is nanotechnological. DENTAL ANESTHESIA ANALYSIS.- This anesthesia is administered in the public system. All anesthetics, all of them. And we have seen it here, in Brazil, everywhere; all the anesthetics are conta-minated.

CONCLUSIONS.- The doctors observed structures consistent with graphene oxide ribbons. Micro-sheets, luminous points, and bubbles containing self-assembling nanotechnology. The samples are heavily contaminated with particles exceeding the declared quantity and size. TRANSCRIPTION OF RELEVANT REGULATIONS.- This Notarial Record is issued pursuant to Law 4 83 of January 25, 2014, of the Plurinational Notary Office, Article 67 thereof. (Extra-Protocol Notarial Documents). I. The extra-protocol notarial documents are: a) Notarial Records; II. Their characteristics and procedures will be regulated. Article 69.

The Records must be signed by the requesting parties and by whoever makes an observation, when appropriate . II. Prior to preparation, the Notary Public shall inform those present of the nature of the Record and the

request for their intervention to authorize the extra-protocol public instrument, per Supreme Decree No. 2189 of November 19, 2014, Regulations to Law 483, modified by Supreme Decree No. 3946 of June 19, 2019, Article 79. (Extra-Protocol Documents).

I. Extra-protocol documents are instruments in which the Notary Public, at the request of the interested party, makes a report recording their attestation regarding one or more witnessed or known facts, to then be authorized with their signature, rubric, and seal. Article 80. (Action). I. At the beginning of any action, the Notary Public must verify their status and the reason for their presence. II. When there is a risk of being unable to carry out their action or they consider the act to be illegal, a record of the facts will be made in the Record; under this circumstance, the Notary Public is not obliged to remain at the requested location. Article 81.- (Records of Notoriety). I. Records of notoriety serve to verify well-known facts upon which rights can be based and de-clared, and to legitimize personal or patrimonial situations. II. Notarial intervention will be car-ried out upon request and accreditation of a legitimate interest in the fact whose notoriety is intended to be established with the record, with the understanding that the APPLICANT bears re-sponsibility for its assertions.

After performing the microscopic verification of the aforementioned medications and vaccines, this verification is concluded at 10:00 a.m. on July 22, 2025.
